NOTICE OF PROHIBITION

WHEREAS on or about December 9, 2010, Stan Roberson (“Roberson”) was convicted of a Contempt of Court, C.R.C.P. 107 in connection with his employment at Her Majesty’s Credit Union in Denver, Colorado;

WHEREAS a violation of C.R.C.P. 107 is a criminal offense involving dishonesty and breach of trust;

NOW, THEREFORE, YOU ARE HEREBY NOTIFIED THAT:

1. Pursuant to 12 U.S. C. § 1785(d)(1)(A) and 12 U.S.C. § 1829(a)(1)(A), Roberson is prohibited from becoming an “institution affiliated party” of any insured depository institution, as defined in 12 U.S.C. § 1786(r); otherwise participating, directly or indirectly, in the conduct of the affairs of any insured depository institution; and owning or controlling, directly or indirectly, any insured depository institution;

2. Pursuant to 12 U.S. C. § 1785(d)(1)(B) and 12 U.S.C. § 1829(a)(1)(B), no insured depository institution may permit Roberson to engage in any conduct or continue in any relationship prohibited in paragraph 1 above;


3. Pursuant to 12 U.S.C. § 1785(d)(3) and 12 U.S.C. § 1829(b), whoever knowingly violates paragraph 1 or 2 above is subject to a fine of not more than \$1 million for each day such prohibition is violated, or imprisonment for not more than five (5) years, or both;

4. The "Order for Commitment to Jail" filed December 9, 2010, Case Number 2010CV 4655, is made a part hereof and is incorporated herein by reference; and

5. This Notice of Prohibition shall be effective and enforceable on the date of set forth below.

This Order shall not prohibit the Sheriff from deducting good time for the sentence in accordance with sections 17-26-109 and 17-26-115, C.R.S.
