NOTICE OF PROHIBITION

WHEREAS on or about September 6, 2012, Kathleen Maheux ("Maheux") entered a plea of guilty to the charge of Theft by Unauthorized Taking or Transfer, Me. Rev. Stat. Ann. tit. 17-A, § 353(1)(B)(4), in the Androscoggin County Superior Court of the State of Maine, in connection with her employment at Rainbow Federal Credit Union;

WHEREAS a violation of Me. Rev. Stat. Ann. tit. 17-A, § 353(1)(B)(4) is a criminal offense involving dishonesty and breach of trust;

NOW, THEREFORE, YOU ARE HEREBY NOTIFIED THAT:

1. Pursuant to 12 U.S. C. § 1785(d)(1)(A) and 12 U.S.C. § 1829(a)(1)(A), Maheux is prohibited from becoming an "institution affiliated party" of any insured depository institution, as defined in 12 U.S.C. § 1786(r); otherwise participating, directly or indirectly, in the conduct of the affairs of any insured depository institution; and owning or controlling, directly or indirectly, any insured depository institution;

- 2. Pursuant to 12 U.S. C. § 1785(d)(1)(B) and 12 U.S.C. § 1829(a)(1)(B), no insured depository institution may permit Maheux to engage in any conduct or continue in any relationship prohibited in paragraph 1 above;
- 3. Pursuant to 12 U.S.C. § 1785(d)(3) and 12 U.S.C. § 1829(b), whoever knowingly violates paragraph 1 or 2 above is subject to a fine of not more than \$1 million for each day such prohibition is violated, or imprisonment for not more than five (5) years, or both;
- 4. The "Docket Record" document, Docket No. AUBSC-CR-2012-00510, is made a part hereof and incorporated herein by reference; and
- 5. This Notice of Prohibition shall be effective and enforceable on the date set forth below.
