NOTICE OF PROHIBITION

WHEREAS on or about October 14, 2016, Marquis D. James ("James") was re-admitted into a pretrial intervention program with respect to the charge of Theft by Unlawful Taking, N.J.S.A. § 2C:20-3(a), in the Superior Court of New Jersey, in connection with his employment at Xcel Federal Credit Union;

WHEREAS a violation of N.J.S.A. § 2C:20-3(a) is a criminal offense involving dishonesty and breach of trust;

NOW, THEREFORE, YOU ARE HEREBY NOTIFIED THAT:

1. Pursuant to 12 U.S. C. § 1785(d)(1)(A) and 12 U.S.C. § 1829(a)(1)(A), James is prohibited from becoming an "institution affiliated party" of any insured depository institution, as defined in 12 U.S.C. § 1786(r); otherwise participating, directly or indirectly, in the conduct of the affairs of any insured depository institution; and owning or controlling, directly or indirectly, any insured depository institution;

2. Pursuant to 12 U.S. C. § 1785(d)(1)(B) and 12 U.S.C. § 1829(a)(1)(B), no insured depository institution may permit James to engage in any conduct or continue in any relationship prohibited in paragraph 1 above;

3. Pursuant to 12 U.S.C. § 1785(d)(3) and 12 U.S.C. § 1829(b), whoever knowingly violates paragraph 1 or 2 above is subject to a fine of not more than \$1 million for each day such prohibition is violated, or imprisonment for not more than five (5) years, or both;

4. The two documents from the Criminal Branch of the Superior Court of New Jersey (Hudson County), Accusation No. 22-01-15, are made a part hereof and is incorporated herein by reference; and
